

# SHARE THE REDBACKS PETITION COMPETITION

## Competition Terms and Conditions

### 1. Introduction

1.1. These terms and conditions govern the “Share the Petition Competition (the Competition)” conducted by The Perth Basketball Association (the "Promoter").

1.2. By entering the Competition, participants agree to be bound by these terms and conditions.

### 2. Eligibility

2.1. Anyone is eligible to enter.

### 3. How to enter

3.1. To enter the Competition, participants must complete the online entry form available [here](#). The form asks for the participant's contact details and the surname of ten people with whom the petition link has been shared.

3.2. Ten (10) bonus entries will be awarded to those participants who can share the petition with a wide audience (for example, organise for their school to include a link to the petition on its app, website or newsletter, or organise for a social media account not linked to the promoter and with more than 500 followers to post the petition link). Participants who want to activate ten bonus entries must complete [this form](#).

3.3. The Competition opens on Friday 19 July.

3.4. Entries must be received by 11.30pm Sunday 4 August 2024 (AWST). Entries received after this time will not be considered.

3.5. Participants may submit as many entries as they like.

### 4. Prizes

4.1. The prizes for the Competition are as follows:

- A family pass (2 adult, 2 children) to a Perth Wildcats basketball game at RAC Arena, Perth (date and time to be confirmed with the winner)
- A Hoops Heaven voucher to the value of \$200
- A family pass (2 adult, 2 children) to a Hoops Fest double-header in Perth (date and time to be confirmed with the winner)
- A training session with one of the Promoter’s NBL1 West teams

4.2. An early-bird prize of a \$15 Guzman y Gomez gift card will be awarded to the first 50 competition participants.

4.3. The prizes are non-transferable, non-exchangeable, and not redeemable for cash or other prizes.

4.4. The Promoter reserves the right to substitute the prize with another of equal or greater value if the original prize is unavailable.

5.1. Winners will be drawn at random from all eligible entries received.

5.2. The draw will take place on Monday 5 August 2024 (AWST) at Leisure Life, Victoria Park.

5.3. The winners will be notified by email or phone within 5 days of the draw.

5.4. If a winner does not respond within 5 days of being notified, the winner forfeits the prize, and the Promoter reserves the right to select another winner.

5.5. The names of the competition winners will be published on the Promoter's website and social media channels.

## **6. Publicity**

6.1. By entering the Competition, participants agree to the use of their name and likeness for promotional purposes without additional compensation, except where prohibited by law.

7.2. Participants' personal information will be used for the purposes of conducting the Competition and will not be disclosed to third parties without the participant's consent.

8.1. The Promoter reserves the right to cancel, suspend, or modify the Competition if it is not capable of running as planned due to technical failures, unauthorised intervention, or any other causes beyond the Promoter's control.

8.2. The Promoter's decision in relation to any aspect of the Competition is final and binding on every entrant and no correspondence will be entered into.

8.3. The Competition and these terms and conditions are governed by the laws of Western Australia.
